#### Research Interests

- -Contemporary political theory and intellectual history: history of political and economic thought (1945-present), history of American and British liberalism, transhumanism, posthumanism, feminist theory, history of the social sciences, political history of future ideas
- -History of science and technology: history of artificial intelligence, history of computer engineering and technologies, science and technology studies

# Current research projects

- -In the Name of Posthumanity: Visions and Justifications of Liberal Order in Contemporary Anglophone Transhumanism. The book traces the history of contemporary Anglo-American transhumanism. Transhumanism involves biological, technological, and political ideas and practices to transform the human condition, ranging from the enhancement of individual capacities to the overcoming of planetary boundaries. Focusing on Anglo-American settings from the early 1960s onwards, it argues that transhumanism after WWII turned into a set of attempts to safeguard the liberal future. It demonstrates how transhumanist projects and arguments drew from, appropriated, and departed from conventional repertoires of liberal discourse ranging from libertarianism to utilitarianism. Bringing together the history of liberal political thought with the history of science and technology from the postwar on, it contributes to clarifying the role of technoscientific practices and imaginaries in reshaping contemporary liberalism.
- -Gendering the Machine: Feminist Ethics in Artificial Intelligence (1960s-present). This research investigates the historical role of feminist thought and activism in artificial intelligence scientific project, from the 1960s onwards. Focusing notably on the Logo project at MIT and Edinburgh's AI lab, it studies how Logo was recast from a libertarian to a feminist tool, and how feminist ethics, epistemology, and developmental psychology were rearticulated in this context. It follows the transnational circulation and transformation of ethics and gender justice norms and their reinterpretation and appropriation by scientists and industry actors. This contributes to the "hidden history" of women and feminist activism in AI, to the material history of AI models and software, and to the history of AI as a human science whose ambitions were shaped by ethical, psychological, and political philosophical debates of the time.
